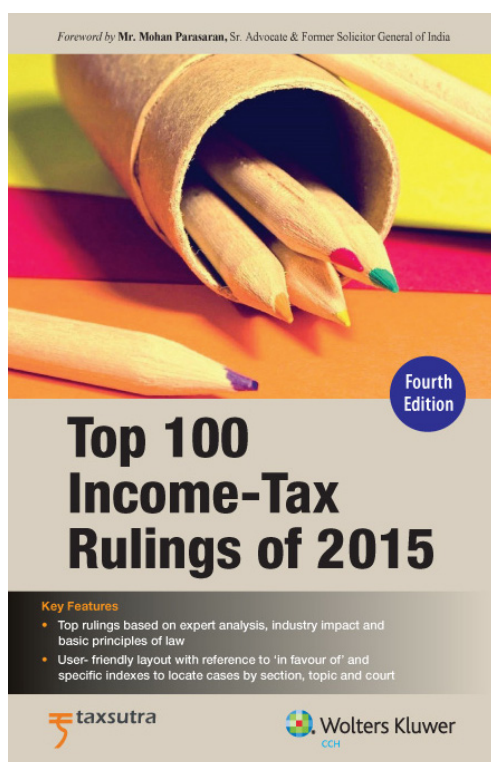


Taxsutra & CCH present Book titled - Top 100 Income Tax & Indirect Tax Rulings of 2015!

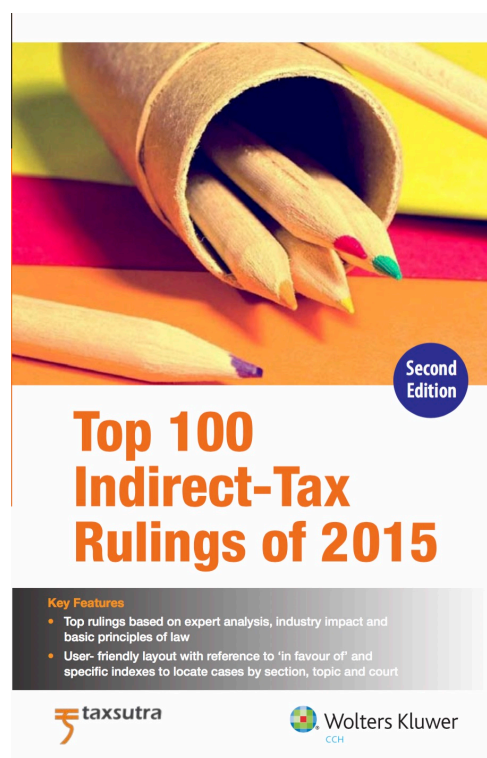
